of the “Corruption Risks in the Field of Education” Anti-Corruption Event

On 15 July, 2016 the Armenian Lawyers’ Association is organising an anti-corruption event entitled “Corruption Risks in the Field of Education”. The event will be held in Darist Hotel, Kapan. The event is aimed at revealing the corruption risks in the field of education, as well as outlining respective solutions to the existing problems.

The event is organised in the scope of the “Multi-Faceted Anti-Corruption Promotion” project funded by the EU and co-funded by the OSCE Office in Yerevan. Representatives from the EU Delegation to Armenia, the OSCE Office in Yerevan, the RA Government, other state bodies, governing bodies of Syunik Region, civil society organisations and mass media, as well as the Armenian Lawyers’ Association, including the experts of the “Multi-Faceted Anti-Corruption Promotion”, Project will attend the event.

Mr. Karen Zadoyan, the President of the Armenian Lawyers’ Association (ALA), Ms. Naira Gyulnazaryan, the Coordinator of Anti-Corruption Projects at the OSCE Office in Yerevan, Mr. Vardan Davtyan, a Deputy Governor of Syunik, Mr. Ashot Hayrapetyan, the Mayor of Kapan, and Ms. Marine Aghajanyan, the Chief Specialist/Acting Head of the Development Programme and Monitoring Department of the Staff of the RA Ministry of Science and Education, will give welcoming speeches at the event.

The welcoming speeches will be followed by reports and presentations on prevention of corruption, the role and importance of anti-corruption education in the scope of civic education, the reforms implemented in the field of education, as well as the importance of introducing the institute of anti-corruption audit in educational institutions.

The suggestions, after being summarised in the event report, will further be sent to the relevant state bodies, which will contribute to the implementation of reforms in the field.

The project aims to increase the role of the Civil Society Organisations (CSOs) in promoting anti-corruption reforms and their implementation. In the framework of the project the capacity of CSOs and the media to engage in monitoring and watchdog activities will be built. Anti-corruption training workshops will be organised throughout Armenia with the purpose of enabling CSOs and media organisations to better comprehend the issues related to anti-corruption and freedom of information. These activities aim at deepening the existing opportunities for carrying out anti-corruption activities. Small grants will be given for raising the effectiveness of public monitoring and implementation of appropriate monitoring, watchdog and investigative activities. A sustainable dialogue between CSOs and the Government will be developed with the participation of CSOs, to strengthen the anti-corruption institutional mechanisms.

The project is funded by the European Union and co-funded by the OSCE Office in Yerevan. It is implemented by the “Armenian Lawyers’ Association” NGO – Applicant and “Freedom of Information Center” NGO – Partner. The project duration is 3 years (January 2014 – December 2016) and the budget is 650,000 EUR, of which 585,000 EUR was contributed by the EU and 31,117 EUR was contributed by the OSCE Office in Yerevan.

Armenian Lawyers’ Association (ALA) was established in 1995 with a Mission to promote to the establishment of the rule of law, democracy and formation of the civil society in Armenia, where the people are aware of their rights and where their rights are protected. Before February 2016, ALA was called Armenian Young Lawyers Association.

Freedom of Information Center (FOI) operates over 10 years. The Mission of FOI is to promote application of the RA Freedom of Information Law, contribute to the transparency and openness of the Armenian government system and to stimulate civic society’s involvement in the governance system.
