Constructive Dialogue Network of Armenian CSOs

In November 2017, the Comprehensive and Extended Partnership Agreement (CEPA) was signed between the Republic of Armenia and the European Union.

A Civil Society Platform will be created by virtue of Article 366 of the Agreement, which will serve as a platform for meetings and exchanging of opinions and will be comprised of representatives of the European Union's civil society, including members of the European Economic and Social Committee (EESC), and the representatives of civil society organizations, networks and platforms of the Republic of Armenia..

In this process, the constructive dialogue network of Armenian CSO's attaches particular importance to the strict adherence to principles that will shape the civil society platform, namely: transparency, inclusiveness and the principles of rotation. Of course, providing the above principles is not an end in itself; in the forming of the platform they involve the combining of forces and the participation of key performers of civil society organizations in cooperative and solidary conditions.

The Constructive Dialogue Network of Armenian CSOs has announced that it has decided to actively participate and be involved in the Civil Society Platform which is to be created in the framework of CEPA, to support the Armenian National Platform of the Eastern Partnership Civil Society Forum, committing itself to providing expert assistance in developing/improving public policies in individual areas of CEPA, in order to implement their public monitoring and evaluation.
